- Implementing a **first members needs assessment** to better gauge member needs for future program development.

AMWA CEO Tom Dobbins, CAE

New CEO

Tom Dobbins, CAE, stepped into the role as AMWA's new Chief Executive Officer (CEO) in June 2022. An experienced association executive, Dobbins previously served as CEO of the Aluminum Association and the American Composites Manufacturers Association. He also led the government affairs program at the American Council of Engineering Companies. In addition, he held senior roles on Capitol Hill and in the executive branch. At prior associations, Dobbins has been instrumental in driving organizational growth and working with Congress to pass several infrastructure laws.

"It is an honor to join such a prestigious organization," Dobbins stated. "There is nothing more fundamental to public health than water. I remain committed to AMWA's mission to advocate for policies that make drinking water abundant, safe, and affordable to all Americans."

After taking the helm of the association, Dobbins wasted no time communicating and charting a clear path for AMWA's future by collaborating with the Board and other members, the AMWA team, leaders at water sector associations, and others in various industries. His desire is to ensure AMWA and partners elevate the value of water across the country.

AMWA President Angela Licata stated, "This is an important time for the association and its members, who face many challenges including cyber security, resilience in the face of climate change, stringent lead and copper rules and increasing concern for emerging contaminants, and renewing aging equipment and delivery systems. With Tom on the team, the AMWA staff will continue to represent the best interests of the communities we represent with policymakers and provide the members with the information and tools needed to serve our customers."

ADVOCACY

Resilience and Preparedness

AMWA influences legislative and regulatory policy decisions that impact the water sector, including advocating for funding for water infrastructure, promoting sustainable and secure water management practices, and supporting sound scientific regulations that enhance the quality and safety of the drinking water supply.

• Culminating more than a decade of work, AMWA notched a victory in December when Congress appropriated the first-ever funding to the Midsize and Large Drinking Water System Infrastructure Resilience and Sustainability Program, a new EPA program intended to help drinking water systems prepare their infrastructure to withstand the effects. of climate change, extreme weather, and cyber attacks. AMWA originally conceived of the program in 2009, and since that time worked tirelessly with members of Congress on both sides of the aisle to make it a reality. The program was formally authorized as part of the Infrastructure Investment

AMWA Chief Advocacy Officer Dan Hartnett, former EPA Managing Director for Infrastructure Implementation Karen Dettmer, and Buffalo Sewer Authority General Manager O.J. McFoy attend EPA's Commemoration of the 50th Anniversary of the Clean Water Act. and Jobs Act of 2021 and received its first appropriation – \$5 million – as part of Congress' FY23 omnibus spending legislation.

• Seeking to expand water systems' access to WaterISAC, AMWA successfully persuaded Sen. Ed Markey to agree to sponsor legislation that would establish a new EPA program that would promote utility participation in the information sharing network, including by subsidizing the membership costs of some water systems. Working with Sen. Markey's staff, AMWA developed a draft of the Water System Threat Preparedness and Resilience Act. As of the end of 2022 AMWA was in talks with a Senate Republican office about serving as the lead cosponsor, with the goal of introducing the bill early in 2023.





letters to Congress to share the association's perspective on timely policy issues like infrastructure funding, PFAS regulation, and maintaining the availability of critical water treatment chemicals.

Over

• AMWA worked to highlight the need for further investments and improved federal coordination to aid the water sector's ability to address climate change and its effects on water systems. AMWA reviewed the EPA Office of Water (OW) climate adaptation implementation plan and used its response as a springboard to have a direct discussion between AMWA members and key OW staff. During this roundtable, AMWA members reiterated the importance of integrating climate considerations into the Safe Drinking Water Act and Clean Water Act actions and programs and encouraged EPA OW staff to consider a holistic, long-term assessment of potential tradeoffs involved in climate mitigation and adaptation and statutory obligations under the laws.

Lead Service Line Replacement

• In response to an issue raised by Denver Water, AMWA developed legislation to help water systems more efficiently finance full lead service line replacement projects using tax-exempt bonds. The association

successfully recruited Rep. Dan Kildee and Sen. Michael Bennet to introduce the **Financing Lead Out of Water (FLOW) Act** in the House and Senate, respectively, with Rep. Kildee announcing the bill during a speaking engagement at AMWA's 2022 Water Policy Conference. By the end of the year the bill had attracted 13 cosponsors in the House and 6 in the Senate and was well-positioned for inclusion in a future tax legislative vehicle.

AMWA staff consulted with the association's **Regulatory Committee** to provide EPA with feedback on its draft **"Guidance for Developing and Maintaining a Service Line Inventory"** intended to help utilities comply with requirements of the **Lead and Copper Rule (LCR) Revisions.** In December, EPA invited AMWA to participate in a Federalism Consultation on potential revisions to the LCR, also known as **LCR Improvements (LCRI)**. AMWA submitted comments with input from the Regulatory Committee and anticipates a proposed rule in September 2023.

PFAS Regulations

- AMWA remained united with other water sector organizations in providing comments to EPA after the release of its proposed rule to designate PFOA and PFOS as hazardous substances under CERCLA. AMWA joined others in expressing concerns over the lack of liability protections given to drinking and wastewater utilities as passive receivers.
- In cooperation with other water and wastewater sector organizations, AMWA contributed to the development of marker legislation to demonstrate how a narrowly tailored revision to the CERCLA statute could protect drinking water and wastewater systems from incurring cleanup liability related to **PFAS** removed from water supplies. AMWA continuously briefed lawmakers and staff about the need for these liability protections, and intends to continue these efforts when Congress turns its attention to PFAS legislation in 2023.

• In anticipation of the upcoming National Primary Drinking Water Regulation of PFOA and PFOS, AMWA staff met with EPA on numerous occasions to discuss potential elements of the rulemaking. In April, AMWA provided EPA with input as part of a Federalism Consultation on implementation and compliance challenges as well as environmental justice considerations.

MDBP Rule Revisions

• AMWA staff actively supported Rosemary Menard, Director of the City of Santa Cruz Water Department, in her participation on the National Drinking Water Advisory Committee (NDWAC) Microbial and Disinfection Byproducts (MDBP) Rule Revisions Working Group. The group is charged with providing the NDWAC, and ultimately EPA, "with advice and recommendations on key issues related to potential revisions to MDBP rules." At the end of 2022, AMWA recommended Laura Cummings, Executive Director at Southeast Morris County Municipal Utilities Authority and AMWA Regulatory Committee chair, give a presentation in early 2023 to the Working Group giving the large system perspective on rule implementation and compliance issues.

Cybersecurity

• In response to increasing chatter in Washington about potential federal regulations governing water system cybersecurity practices, AMWA proactively drafted a proposal that would set targets for water system cyber preparedness and award funding opportunities to systems working in good faith to hit those targets. AMWA has begun to circulate this "Water Resilience Accreditation Commission" concept on Capitol Hill to influence any congressional action on water system cybersecurity in 2023 or beyond.

comment letters submitted on issues affecting the water sector, including Waters of the United States definition, Build America Buy America Waivers, Risk Management Program revisions, Consumer Confidence Report requirements, and many more. statements submitted for the records of House and Senate hearings and an advocacy packet of drinking water policy priorities developed for circulation on Capitol Hill during the 2022 Water Policy Conference.

Environmental Justice and Equity

• Responding to the administration's interest in advancing environmental justice, AMWA continuously tracked and responded to environmental justice initiatives produced by the Council on Environmental Quality (CEQ). Furthermore, AMWA began networking with federal agencies to highlight a key discrepancy between federal intentions of the Justice40 initiative, which aims to provide 40 percent of federal funds

in certain programs to disadvantaged communities, and the reality that many AMWA members are excluded from receiving **Drinking Water State Revolving Fund** dollars targeted to disadvantaged communities through state policies. AMWA highlighted this discrepancy in comment letters and other communications to CEQ and began discussions across federal agencies to ensure that disadvantaged communities in metropolitan areas are prioritized for targeted federal investment.

MEMBER ENGAGEMENT

Over the past year, AMWA members remained actively engaged in the organization. Members attended conferences and webinars and led association initiatives by participating on committees and work groups. This activity level is a testament to the dedication of members, the Board, and staff. AMWA has increased member engagement over the past year by:

- Convening a stellar Water Policy Conference highlighting infrastructure funding environmental justice, lead service line replacements, and more.
- Providing a first-class program addressing organizational leadership, cybersecurity, and affordability at the Executive Management Conference.
- Partnering with CDM Smith on a webinar to help members address concerns about PFAS treatment methods, utility liability, and potential regulatory impacts.

AMWA also encouraged member participation by:

- Visiting utilities to learn more about their management and operations.
- Enhancing communications by streamlining newsletters and increasing social media posts.

Member Needs Assessment

As a part of the process, AMWA began implementing its **first-ever comprehensive member survey** in November. AMWA enlisted the aid of an outside consultant to conduct thorough interviews of internal and external stakeholders to get valuable member feedback.

- Advocacy is a key driver of the AMWA member experience.

AMWA, in partnership with Raftelis, condcted the eighth biennial INSIGHT survey in the fall to update the utility financial information resource. AMWA designed the program to capture timely, relevant, and authoritative data on the current water utility financial environment from participating member utilities and deliver that data in an Excel spreadsheet and via a user-friendly online dashboard.

The INSIGHT database provides useful, comparable financial information that utility executives, CFOs, and others can apply to their financial planning and communicating with key constituencies on pertinent issues. Members can use the dashboard and spreadsheet to compare their data to other utilities in affordability programs, capital assets, CIP budgets, debt, expense categories, rate structures, revenue sources, and more. Former Director of Phoenix Water Kathryn Sorensen used INSIGHT to demonstrate that the utility's rates were affordable. "We didn't prepare slides...we brought up the Dashboard live with the Rates Advisory Committee and analyzed a few key metrics in real-time...to get the committee to acknowledge that the rates are affordable. It was a key step in the discussion."

The database contains information gathered from comprehensive questions, capturing a treasure-trove of data from AMWA member utilities. It provides all the data from all previous surveys and over a decade of information to support trending analyses. The data reflects input only from metropolitan drinking water systems, allowing uniquely meaningful comparisons.

AMWA BY THE NUMBERS

The AMWA Finance Committee played an active role in the development and execution of the association's 2022 budget. Despite a slow start, the staff worked hard to renew members, which is an overwhelming source of revenue. The association was also adept at watching expenses. The combination led to a healthy surplus, which leadership put into a Management Fund, allowing funding for 2023 initiatives.
